 my soule unto Almightie god. And my body to be buried in the
 Churchyard of Church. And to be buried in the
 Churchyard to be distributed to the poor of the
 distribution of myne Executor. Item I give unto Elizabeth
 my wife to be payed within one month after my death
 the sum of twenty pound I give unto my wife Elizabeth
 Item I give the house and tenement unto Mary Adon of the County of
 Henry Adon County of Surrey of lawful language and age
 to be delivered by myne Executor unto my daughter Elizabeth
 the first of the month of June next ensuing my decease. by whom
 to be kept out to use until she saye Mary Adon accomplish
 the age of 21 years or the marriage daye. wch shall happen
 first. Item I give unto the sayd Mary Adon one hundred
 pound. wch all things shalbe belonging, and my last will
 test, my wedding ringe and one piece of gold of 20 to be
 delivered at the daye of her marriage daye or sooner if
 consent of both parties. And if it is my will that if she saye
 Mary Adon shall departe by death before she shall
 come unto the age of 21 years or be married that she
 shall receive the sum of 100 pound and all other legacies
 shalbe paid unto her by myne Executor and wch money she
 shall use and spend as she shall think good. Item I will
 the distribute unto the residue of my children of Henry Adon
 wch shall be her livinge to be distributed by equal portions
 the first of my goods and chattels in my last will
 legacies and funerall charges, I give and bequeath
 unto Anthony Adon my son in law the sum of 200 pound
 and myne Executor. And I constitute and appointe my
 well beloved friends Thomas Knight and Thomas Currier
 oversight unto the my last will and Testament and give unto
 every of them the sum of 100 pound and chargeable
 for the same shalbe such as they shall see good and convenient
 to be done. In witness whereof I have subscribed with my hand
 the daye and year first above written in the presence
 of just witnesses named.
