underhande I thus give vnto James my sonne some ten pounde  
next after my decease I thus give vnto the church of

at shrewsbury I thus give vnto my daughter Jane some

of all that I have not given nor bequeathed by this  
my p'p'rt testamēt my deeth & last will & testamēt in  
body or otherwise & this my p'p'rt last will & testamēt in  
all thinge performed & fulfilled & accomplished I give fully & wholly  
vnto Edward Card my sonne next after my decease I make my full  
& sole executor of this my p'p'rt last will & testamēt. And  
I appoint my truste & wellbelovyd friende in christe Hugh  
Card my brother & John Leggar to be my overseers & assistants  
to my executor for the better performance of this my p'p'rt testamēt  
I thus give vnto the church of shrewsbury some some some some  
residuelle some & charge in that behalfe susteyned & yett  
Lordes James my sonne & the firste & blyssed witnesse John Leggar  
& Edward Palliott
