 first was fashjoned in my last will notwithstandinge doubtinge but accordinge to the desire of my
 friends att the latter daye of shall receive it againe accordinge to the order of alms for god w^{ch}
 yet is able to suborne all things to himselfe not a reasonable mortall soule and weak body as it is
 now, but an incorruptible mortall stronge & perfect body in all points like unto the body of my lord
 and Saviour Jesus Christ and to be buried att the discretion of mye Executors. Item I make Thomas
 ffremantle my chiefe sole executor of this my last will and testament notwithstandinge but
 yet will equally distribute the same goods w^{ch} I shall leave behinde mee amongst my poore friends
 In witness whereof I make Thomas ffremantle and James ffremantle sole Executors of this my last will and
 testament. And I give to every of them by these my last will and testament, w^{ch} I have subscribed with
 my hand and sealed upon the daye and year above written
