unto John Dally his son of John of Easton Laborer by name
of Edward Ellings to be paid unto him at my decease no
less than fiftie and bound an aguient to a trade in potte or more
by his son Ellings, that y^e he not bound ten a yarde or two to
a tradesman to paint his name more to him no less than
to cōfesse age of 100 years, and all the rest of my good
to al least my debts being paid to y^e value of my laboring leaff
Mangell Abingdon. Also I make my full and whole exposito
of y^e rest of my last will and testament, And so for soode sake
hereunto, given me, in London before Edward Exposito
my sonne he said and y^e date whereon:
