

What We Do:

- Provide Archaeological Planning Advice to the 11 Surrey District and Borough Council planning authorities, and to Surrey County Council itself
- Provide Historic Buildings and Conservation Area Planning Advice Services to SCC and Tandridge District Council.
- Advise SCC on the maintenance and upkeep of its own heritage properties and archaeological sites
- Maintain and enhance the Surrey Historic Environment Record, and make this available to the public
- Host the Surrey Finds Liaison Officer post
- Provide general heritage and archaeological advice to the public
- Coordinate the Historic Environment Group/Forum
- Carry out certain special projects related to heritage (e.g. Local Listing)



What We Do:

- We comment and advise and write heritage/archaeological planning policy for the County and the Districts and Boroughs
- We comment and advise on planning applications that affect heritage assets/archaeology & recommend where investigative work needs to take place
- We respond to and comment on Government consultations and proposals that affect heritage
- We monitor archaeological work being carried out by professional organisations in the county to ensure standards compliance
- We collate and update the Historic Environment Record to keep it as accurate as possible about what we know of Surrey's heritage
- We liaise and work with the other heritage organisations in Surrey
- We will help the public where we can with heritage queries either by answering them or directing them to the correct authorities
- We advise the Surrey DAC on church-related developments that affect archaeology
- We represent Surrey on the National heritage bodies (HER Forum, ALGAO, Historic England, ClfA, RESCUE, CBA etc.
- Provide emergency archive storage for archaeological material at the Woking Coroner's Court



What We Don't Do:

- Provide Conservation Area and Historic Buildings advice to district or borough councils other than Tandridge – they do this in-house
- Manage Scheduled Monument consents or provide advice on SM management – this falls to Historic England
- Manage the Surrey County Archaeological Unit
- Run the Surrey Museums Partnership
- Provide detailed advice on historic parks and gardens or historic landscapes
- Carry out commercial archaeological or heritage projects (sort of)!
- Conduct outreach activities (see the Unit for that)
